

CTC SOUTH WEST LONDON

RULES for ANNUAL COMPETITIONS

Competition Period: 1st January to 31 December annually.

Entry Qualifications: Only riders who ride regularly with a designated Group of CTC South West London are eligible to enter. Indicate your wish to enter by advising your Section or Club Secretary as soon as possible following the competition period.

Entries: Entries should be submitted in good time before the judging day, which is usually at the end of the second week in January.

Trophies for all competition categories will be held for one year.

Competition Categories:

1. Consistent riding with Club Sections:

- i) The member riding most consistently with his/her nominated Section.
- ii) The member riding most consistently with more than one Section.

Points will be determined for the individual Section and will be recorded weekly. For the Mid Week Wayfarers this will be on the basis of a weekly record and individual returns made on the annual runs/attendance list and submitted to the Secretary. For Cheam and Morden this will be on the basis of the cumulative weekly attendance record for the qualifying period recorded on the Cheam and Morden website.

For **Section Runs** points will be allocated as follows:

- i) One point if you ride to elevenses.
- ii) One point if you ride from elevenses to lunch or directly to lunch. (Maximum for whole day is therefore 2 points).
- iii) One point for a Saturday afternoon.

2. The highest annual mileage (January 1st - December 31st).

- i) by a male rider.
- ii) by a female rider.

A chart showing mileages reliably recorded by a cycle computer, GPS enabled device or map measurer on a weekly basis, will be required as proof for an award winning entry. Estimates may be given and accepted if it can be shown to the Section Secretary and the Awards Sub-Committee that the basis for an estimate is clearly reliable.

3. The most interesting or ambitious ride during the year.

Entries for this competition will be judged on the basis of a written description of the ride, preferably with photographic support. This may include reports published in the Sou'Wester, posted during the year on the CTC SWL website or on other personal blogs that have been widely shared with members of the Club. Entries must be submitted to the Secretary and/or be available online.

4. Photographic Competition:

A photograph showing a bicycle or other unambiguous cycling association, must be posted online, in accordance with the instructions and entry procedure posted on the CTC SWL website. Those without internet access may submit standard sized prints (4" x 6") to the Secretary.

The photographic categories are:

- i) Lady
- ii) Gentleman
- iii) Action
- iv) Scenery/landscape
- v) Building/buildings
- vi) Humorous
- vii) Group (ladies and/or gentlemen)

The award for a winning photograph will be given to the photographer who took the picture, not to the model. The entry must include:

- i) the photographer's name, ii) the category, and iii) a short caption to describe the picture.

Judging: A judging Sub-Committee of three will be appointed annually from the members of the Committee, with authority to co-opt if necessary.

For all categories of all the competitions the Sub-Committee's decision will be final.

Presentations: Awards will be presented at the annual lunch, which is usually held in March.

Publication: The results and entries may be published in the Sou'Wester, on the CTC SWL website or elsewhere unless this is specifically refused by the Award winner.
